The KD value obtained is 0.753 which can be interpreted that the independent variable has a contribution effect of 0.753 or 75.3 % of the Y variable and the other 24.7% is influenced by other factors outside the Y variable. From the results of calculations that have been carried out, Ho rejected and Ha accepted, that is, there is an effect of teacher competence in class on the effectiveness of student learning at MTs Al Muslimin Hamlet IV Paya Pasir Village, Tebing Syahbandar District. The results of the research above are also supported by the results of research on the effect of teacher competence on student learning achievement at Madrasah Ibtidaiyah Al-Washliyah Nagur Village, Tanjung Beringin District, Serdang Bedagai Regency. consulted to the correlation criteria (between 0.400 to 0.597) then the relationship of 0.489 between teacher competence and learning achievement is quite high. While the coefficient of determination (r2 = 0.737) means that there is a contribution of 73.7 % between students' learning motivation on learning outcomes and the remaining 26.3% is influenced by other factors.

The results shown from the two studies that have been carried out can be seen that the two studies both show the magnitude of teacher competence on learning effectiveness as indicated by the results of calculations carried out by the two



researchers. From the similar results obtained that there is an influence of teaching teacher competence on the effectiveness of learning that has been carried out by the two researchers, it can be concluded that the competence of teaching teachers plays an important role in increasing the effectiveness of student learning.

## **IV.CONCLUSIONS**

Based on the results of data analysis and research discussion, the conclusion in this study is that there is an influence of teacher competence in class on the effectiveness of student learning at MTs Al Muslimin Dusun IV Paya Pasir Village, Tebing Syahbandar District, with the contribution effect of 0.753 or 75.3% to variable Y.
